



# Manipal University Jaipur Elected Representation on the Highest Governing Body

The governance structure of a university plays a significant role in shaping its policies, decisions, and future direction. To ensure a diverse and comprehensive perspective, Manipal University Jaipur has established a practice of including elected representation from various stakeholder groups on its highest governing bodies. The significance of this practice, focusing on how students, faculty, and staff elected representatives contribute to the governance process, creates a more inclusive and representative decision-making system.

Elected representation on a university's highest governing body, often referred to as the Board of Trustees, Board of Regents, or similar titles, is an essential element of shared governance. It provides a mechanism for different voices and perspectives to be heard and considered when making important institutional decisions. These elected representatives act as a bridge between the various stakeholders and the university administration, fostering a more transparent and accountable decision-making process.

#### **Students: The Student Voice**

Students are at the heart of any educational institution, and their experiences, needs, and concerns must be represented at the highest level of governance. At Manipal University Jaipur Elected Student Representatives, forms Student Council, advocates for student interests. All the office bearers; President, General Secretary, Treasurer, Cultural Secretary(m/f), Sports Secretary(m/f), Technical Secretary(m/f) and Joint Sports Secretary (m/f) are elected through a fair election process. They bring vital insights into the academic, social, and extracurricular aspects of university life (Annexure 1).





#### Faculty: The Guardians

Elected faculty representatives are professors who contribute to more well-rounded, informed, and representative choices. Manipal University Jaipur has a Faculty Welfare Club, the President is an elected member, contributing to faculty welfare. The representative also bridges the gap between faculty and administration, ensuring that faculty well-being.

#### **Staff: The Operational Experts**

University staff, including administrative, support, and service personnel, play an essential role in the institution's daily operations. Elected staff representatives can address issues related to employment conditions, workplace safety, and operational efficiency. They provide a perspective that ensures the university functions smoothly and that staff members are heard and valued.

The practice of having elected representation on Manipal University Jaipur's highest governing body from students, faculty, and staff is a testament to the commitment of educational institutions to an inclusive and accountable decision-making process. These elected representatives provide diverse perspectives, ensure accountability, and contribute to a more harmonious campus climate.

- Should have cleared all subjects of earlier semesters and should have a CGPA of at <u>least 7.5</u> at the time of application;
- Should neither have been suspended by the institute authorities for any offence nor should have any disciplinary action taken/pending against him/her;
- In the case of applicants for CULTURAL/ TECHNICAL/ SPORTS SECRETARY, he/she should have represented the University events/ any other such activities; and
- Student should have studied for at least 1 year at MUJ.

The respective Class Coordinator of the section is requested to endorse the application form and submit the form to respective Election Coordinator of their school. A Student Council Advisory Board will scrutinize the applications received based on the parameters and announce the short-listed candidates for the post. The decision of the Student Council Advisory Board is deemed final in the shortlisting. A student can apply for a maximum of two posts for which he/she is eligible. In such cases separate applications should be submitted for the posts applied.
