



The context of this communication is to highlight the importance of rural engagement to figure as an integral part of the curriculum of University/College/Deemed University/Technical Institutions. While several institutions have specialised Departments for rural technology, management study etc., it is essential that it becomes a universal feature of the higher education system, in order to impart the muchneeded relevance & practical insight to problems faced by the bulk of the Indian population residing in rural areas.

2. The primary objective of the Unnat Bharat Abhiyan programme being implemented by this Department is to ensure that students of HEIs obtain a structured rural exposure by incorporating the same as part of the academic content. The National Council of Rural Institutes (NCRI), Hyderabad, under the Department of Higher Education is, by mandate, involved the task of promoting core course & add-on curricular interventions for inculcating social responsibility through student engagement with rural communities, especially the villages in proximity of Universities/colleges etc., where the NSS units of the institutions are in interaction with. 
