A. AGENDA FOR DISCUSSION

32AC (A-1): Controller of Examinations

32AC (A-1-1) List of Graduates for the Convocation'21

The Controller of Examinations presented the list of graduating students for the Academic Year 2020-2021.

32AC (A-1-2) Department of Higher Education - Objection

The Controller of Examinations deliberated on the objection raised by the Department of Higher Education regarding printing of Grade-Cards for each Semester along with the date of results published.

- The Grade-Cards/Mark-sheets of Students for Odd and Even Semester are printed after the academic cycle for a year is complete.



- The Department of Higher Education is rejecting the Grade-Cards with objection raised on the process:
 - Printing of Grade cards for ODD and EVEN semester must have the date of result published.
 - Printing must be done after each semester.

Considering the detailing from CoE and suggestions from the External Member, the Council approved the issuance of Grade-Cards semester wise.

32AC (A-2): Registrar Office

- **Academic Audit for 3 Schools of Faculty of Engineering.**

Member Secretary presented the details of External - Academic Audit which was done for 3 Schools of FoE; School of Electrical and Electronics & Communication, School of Automobile, Mechanical and Mechatronics, and School of Computing and Information Technology on 21st & 22nd of September 2021, wherein, Dr D. Boolchandani, Dr Dangayach G.S and Dr Pilli Emmanuel Shubhkar, Professors from MNIT were invited as the External Auditors.

Considering the template and report of academic audit, it was suggested to include Academic Processes as a component of academic auditing and further deliberations can happen in the proposed Curriculum Conclave. It was also suggested to have separate Curriculum Conclave for each of the faculty.

It was informed by the Member Secretary that the local NCC Commander has been contacted who had suggested to further contact the UGC for clarification regarding the issuance of B or C Certificates or it’s equivalence.

Based on the suggestion of the External Member, the Chairman suggested the following action points:



- The course to be taken as an active 1-year participatory course with 3 credits.
- NCC officer at MUJ to certify the active participation of the students enrolled for the course.
- The number of credits earned by the student will not be considered for the CGPA calculation.
- CoE to confirm where the credits earned by the students can be reflected in the individuals marksheet.
- Other action taken points had been circulated to the concerned departments for necessary action.

The Council noted and ratified the action taken on the minutes of 31st Meeting of Academic Council.

It was also suggested to capture the report and data from other MOOC platforms like NPTEL, Swayam which will be beneficial at the time of Accreditation and Rankings. Moreover, it was suggested to have our own MOOC courses with ownership made available in MOOC platforms.

32AC (B-4-4) Department of Mathematics & Statistics

It was suggested to look into the admission criteria 3.3 for M.Arch (Landscape) wherein candidates with Master's degree are expected to apply for another Master Program which will be time consuming. Moreover, it was recommended to keep a shorter period for the bridge course. It was also suggested to look into the possibility of having a 4 years B.Arch program.



32AC (B-6-2) School of Planning & Design

- Rearranging of open elective course in B.Des (Interior Design) from V Sem to VI Sem.
- Inclusion of MOOC courses:
 - As open elective offered by Department: Graphic Design Elements for Non-Designers (ID0051).
 - In M.Des as part of regular course in I Sem.
- Proposed to swap courses between VII and VIII semesters of 4th year of B.Des (Fashion Design) programme.

- Chairman remarked that such arrangements allow for a cross disciplinary teaching which has it's own advantages. He advised that a curriculum can be designed with inputs from Management, Engineering & Law, and can be taken up with joint intervention of Dean FoE & Director SBC.
- Director SBC, to work on the academic workload of SBC and help build the department if additional manpower is required.
