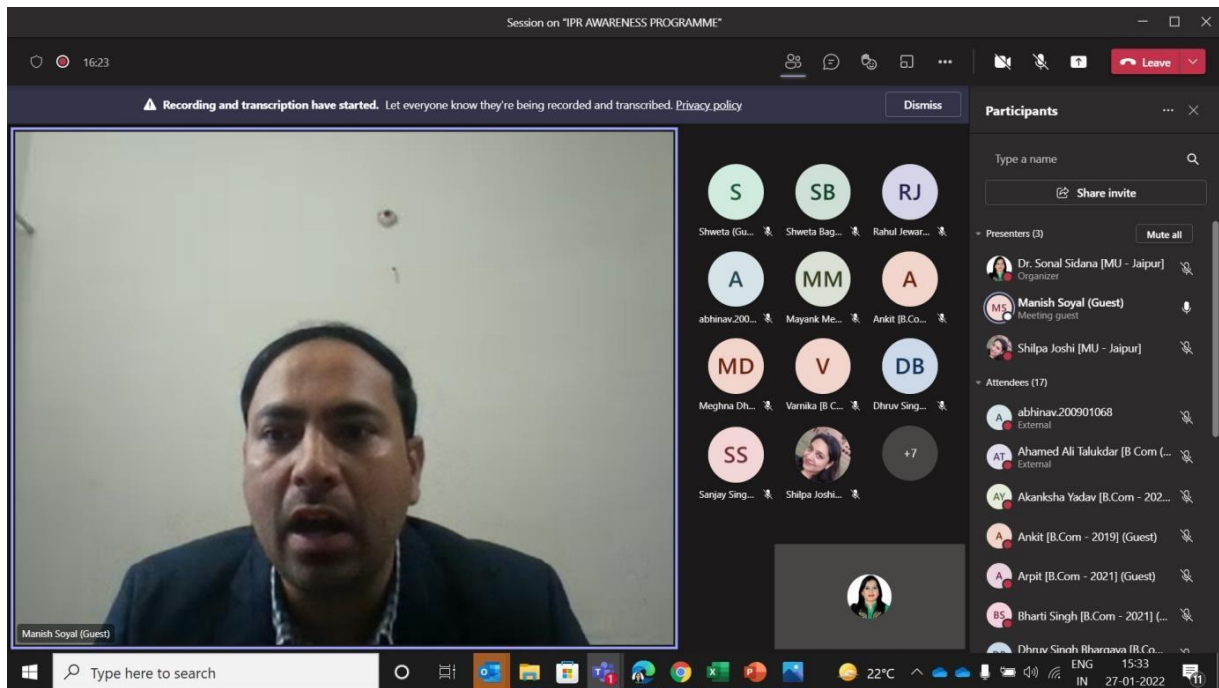



Figure 2 Mr. Manish Soyal explaining the various schemes offered by government for patent and copyright


