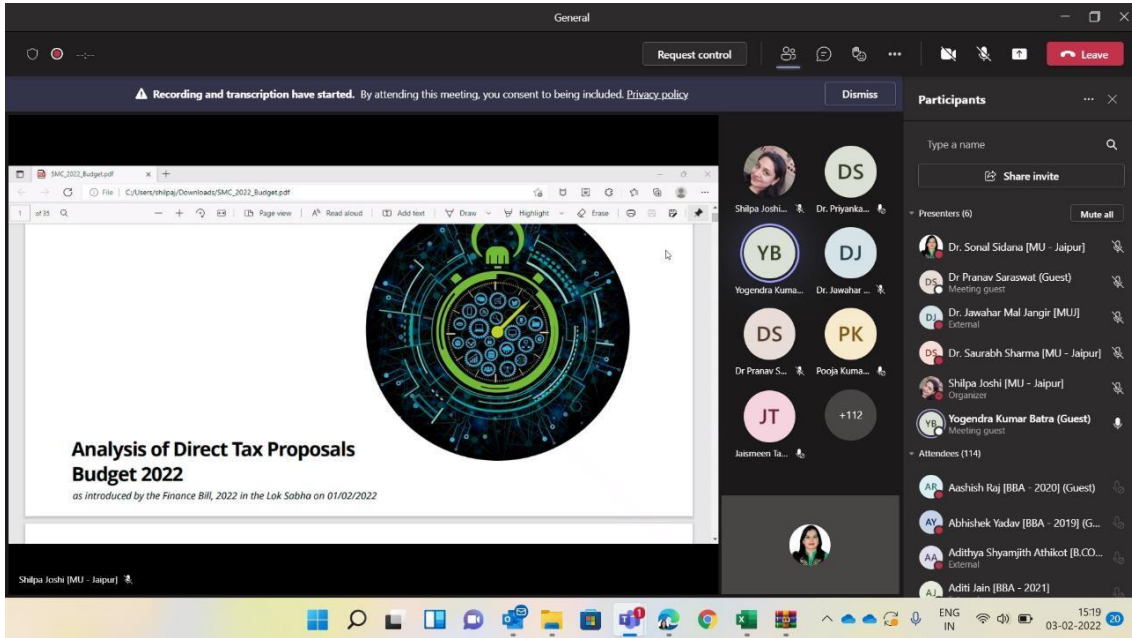


Figure 2 Dr Pranav Saraswat describing tax deduction schemes

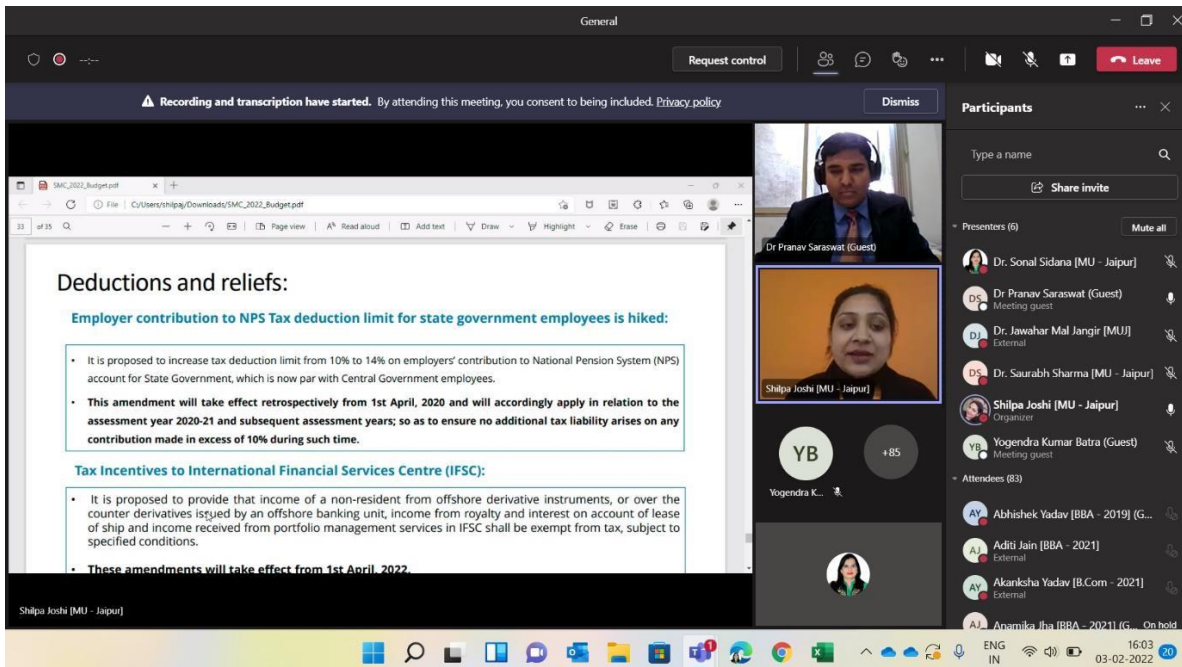


Figure 3 Thanks note given by Director, Jawahar Mal Jangir

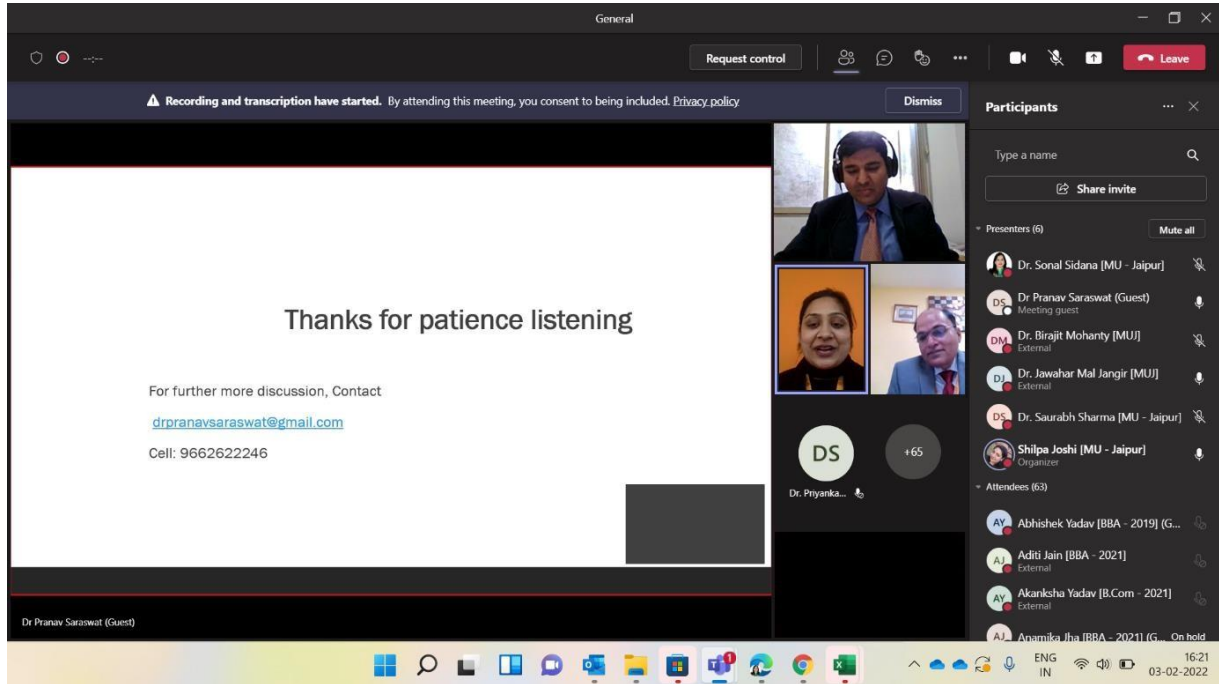
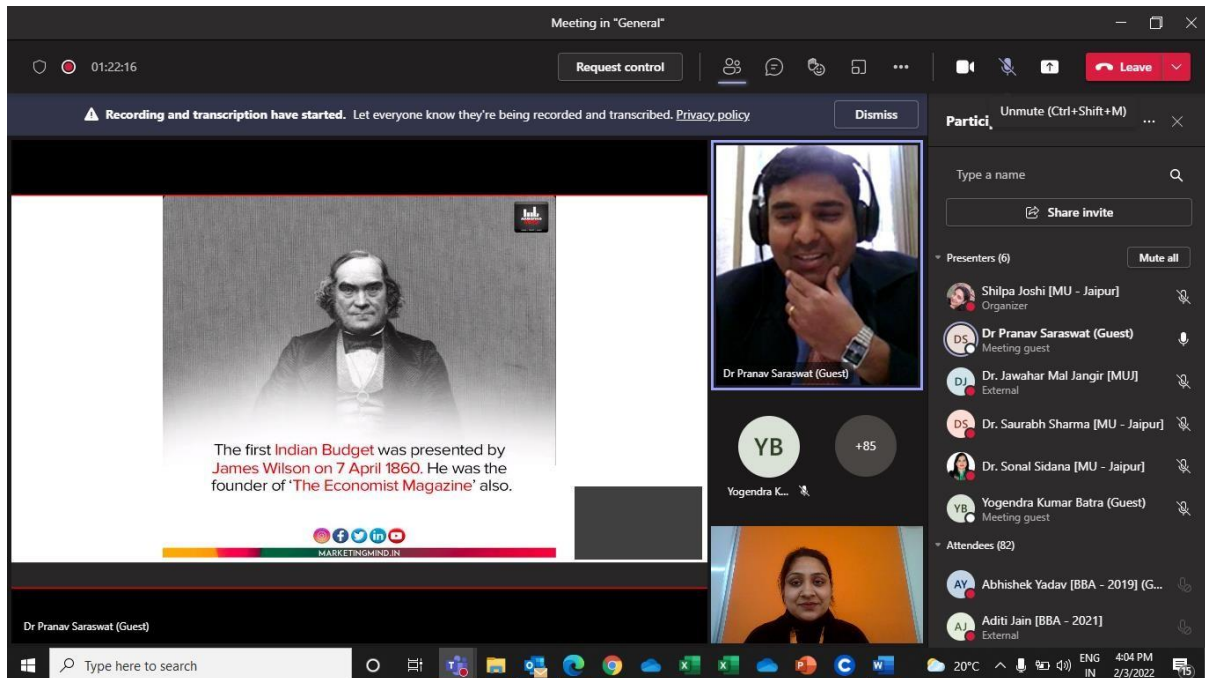
