1. INTRODUCTION OF THE EVENT

After successfully conducting Day 1 of the Legal Awareness on Policy Implementation Camp on 24th January, 2024, the team organized Day 2 of the Camp on 25th January, 2024, in the same venue, Jhalana Basti, to address further legal and administrative issues to discuss its solutions and remedies. One of the primary issues was the lack of awareness among the people about various government schemes that could potentially improve their living standards. Additionally, the team also discovered that many people in the area lacked government-issued cards such as Jan Aadhar, Cheernjeevi, and Mazdoor Dairy, and lack of redressal authority, which are essential for availing various government schemes and benefits, and seeking remedies. With the speaker's expertise in family and criminal law, the discourse aimed to provide practical solutions and actionable insights for the beneficiaries.

2. OBJECTIVES OF THE EVENT

The Camp's objective was to empower rural communities with knowledge of their legal rights and access to resources for effective legal policy implementation. It further aimed to:

- **Raise awareness:** Educate on relevant legal policies, clarify misconceptions, dispel myths.
- **Bridge the knowledge gap:** Inform about legal aid channels, equip with basic legal literacy skills.
- **Empowerment and participation:** Foster agency to seek legal recourse, promote community mobilization for advocacy.
- **Collaboration and capacity building:** Facilitate interaction with legal professionals, identify potential community leaders.
- Tailor content, use accessible communication, partner with local organizations, monitor and evaluate impact.

3. DETAILS OF THE GUESTS

The esteemed guest speaker of the event was Ms. Priyanka Acharya, Advocate, District Court, and High Court, Jaipur.

4. BRIEF DESCRIPTION OF THE EVENT

The event began on Thursday morning. Ms. Krati Bansal, Pro Bono Associate, commenced the event by delivering the welcome address and introducing the event (Day 1). Ms. Upasna Rana, faculty coordinator of Pro Bono Club, MUJ, moderated the event to ensure the smooth functioning of the session for the beneficiaries.



The keynote speaker, Adv. Priyanka Acharya, began by spreading legal awareness on basic legal rights. Remedies for the victims of sexual harassment were also explained. Administrative issues like old-age pension schemes and widow pension schemes were explained with their compensation amounts. Drug addiction and underage drinking were discussed in length as that was a looming crisis in the Basti creating a nuisance in the community and perpetrating most crimes.

Most of the residents were grappling with unemployment and under-paid problems. They alleged that they had worked under the MNREGA scheme for a month but had not received their wages. The compensation for the injury and damage caused by such loss was also iterated instilling hope within the people.

Lack of proper redressal authority was a major problem where the Basti lacked an Anganwadi, a dispensary or a hospital in the vicinity, an elementary school, and inadequate water supply, exacerbated the existing issues of the community.

The speaker addressed these issues and articulated every remedy available to the residents despite their financial backgrounds. She encouraged everyone to amplify their voice and not be afraid of approaching the concerned authorities. She also emphasized the importance of establishing an Anganwadi, dispensaries, and elementary schools in the neighbourhood and sought compliance from the officials of the Basti.

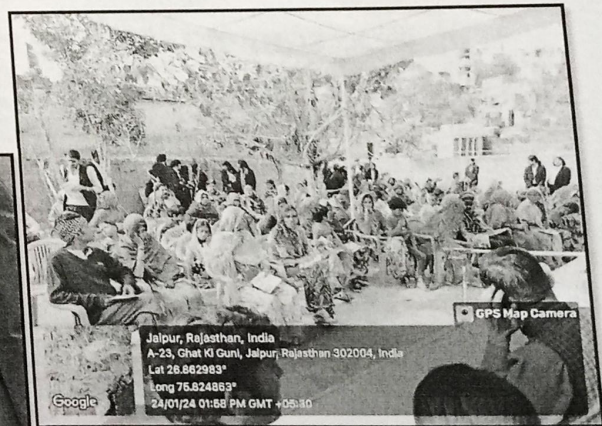
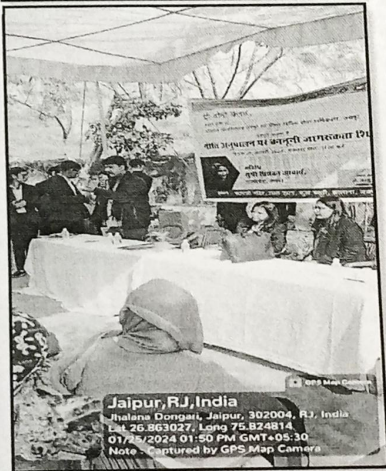
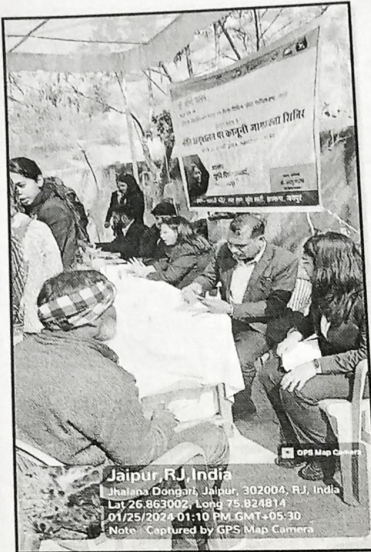
After the conclusion of her discourse, the residents voiced their concerns by seizing the one-on-one interaction with esteemed guest speaker, sharing their problems, and seeking legal assistance. The complaints of each of the beneficiaries were duly registered and the progress in their legal dispute was documented. Our team drafted applications on behalf of the aggrieved residents, and upon obtaining approval from the guest speaker, an advocate at DLSA in Jaipur, we forwarded the applications to DLSA via mail to ensure that the issues were acknowledged. The speaker eloquently addressed general problems such as administrative and social issues, resulting in significant benefits for the audience.

To conclude, informative pamphlets and booklets, presented in Hindi for easy comprehension, were distributed among the participants, covering topics related to cyber frauds and their corresponding solutions. Mr. Vishwas Gupta, the faculty coordinator of the Pro Bono Club at MUJ, delivered the vote of thanks to honour the esteemed guest speaker.


